## ORDINANCE NO. 2025-3

## ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE TRI-CITY PUBLIC LIBRARY DISTRICT FOR THE FISCAL YEAR BEGINNING JULY 1, 2024 AND ENDING JUNE 30, 2025

BE IT ORDAINED by the Board of Library Trustees of the TRI-CITY PUBLIC LIBRARY DISTRICT, of Sangamon County, Illinois, as follows:

**SECTION ONE:** That the total amount of appropriations for all corporate purposes legally made to be collected from the tax levy and other funds of the current fiscal year beginning July 1, 2024 and ending June 30, 2025 is hereby ascertained to be the sum of FOUR HUNDRED TEN THOUSAND FOUR HUNDRED NINETEEN AND 00/100THS DOLLARS (\$410,419.00).

SECTION TWO: That the amount of TWO HUNDRED THIRTY-FOUR THOUSAND THREE HUNDRED FIFTY-FOUR 00/100THS DOLLARS (\$234,353.00), being less than the total of appropriations heretofore legally made which are to be collected from the tax levy and other funds of the current fiscal year of the TRI-CITY PUBLIC LIBRARY DISTRICT for all corporate purposes of the District, as appropriated for the current fiscal year by Ordinance No. 2025-\_\_\_ of the TRI-CITY PUBLIC LIBRARY DISTRICT passed at the legally convened meeting of September 17, 2024, which is hereby incorporated herein and made a part hereof by this reference, be, and the same is, hereby levied upon all of the taxable property in the TRIC-CITY PUBLIC LIBRARY DISTRICT subject to taxation for the current year, the specific amounts as levied being included herein by being placed in separate columns under the heading "To Be Raised By Tax Levy" which appears over the same, the tax so levied being for the current fiscal year of the District, and for the appropriations to be collected from the tax levy, the total of which has been ascertained as aforesaid.
